## Health Guarantee and Purchase Contract

This contract is entered in by Michelle and Dimitri Gonzalez, hereinafter referred to as Boisebulldogs and/or breeder, and \_\_\_\_\_ hereinafter referred to as buyer.

The buyer agrees to purchase a puppy from Boisebulldogs for the price of \$ [enter price]. *You will be contacted within one week after puppies are born. At that time pictures of available puppies will be sent to deposit holders in the order that deposits have been received. We can also do video calls(skype/facetime) to help you make a decision. To protect the health of our puppies, we do not allow in person visits until after pups have had immunizations. You may change your puppy choice to a different available puppy or litter at any time.*

Your deposit in the amount of \$\_\_\_\_\_ was received on [date] via [Payment method] . This amount is applied towards the total purchase price of your puppy. The remaining balance due of \$[balance due] will need to be paid before or at the time of picking up your puppy. If a puppy will be delivered or shipped, payment must be received in full before puppy will be sent. Any delivery charges, if applicable, are additional and not included in the purchase price.

Please make arrangements for paying the balance due prior to picking puppy up. If you are traveling to Boise to pick up your puppy, please be sure payment options have been reviewed and you are aware of how you will be paying. Be aware of the local banks in Boise before you come. It's a sad day to not be able to send puppy home because payment arrangements have not been finalized.

In the event you are unable to pick puppy up at the time he is ready to go home, you will be charged a weekly kenneling fee of \$50 for each week puppy remains in our care after their take home date. Payment for this fee must be received prior to or at the time of pick up of your puppy. If you have not picked up puppy by 9 weeks of age, your claim on the puppy will be forfeit and puppy will be offered for adoption to others. This is not to be mean or take advantage of you, but to ensure our puppies are able to properly bond to their families at the time in their lives that is best. Your deposit will be applied to another available puppy, of this litter or the next available litter, of your choosing. Deposits are not refundable, but are transferable.

The breeder warrants that this puppy is in good health and free of communicable diseases at the time Buyer assumes ownership. A puppy purchased from Michelle and Dimitri Gonzalez is guaranteed against distemper, hepatitis, parvovirus, and coronavirus for four (4) months from date of purchase, provided immunizations are continued, per our vaccination schedule by a licensed veterinarian and normal care is given to the puppy.

Buyer agrees to have the puppy examined by a licensed veterinarian within 72 hours of receipt of the puppy. Failure to do so will void all health guarantees implied or stated within this contract. Breeder is not responsible for any veterinarian expenses incurred at any time.

If as a result of the examination, the veterinarian determines that the puppy is not in good health, then the Buyer shall either elect to keep the puppy or return the puppy along with all executed registration documents to the Breeder for a replacement puppy. If a replacement puppy is required, breeder will provide one as soon as one of equal quality is available.

If the Buyer elects to return the puppy after initial veterinarian examination within the first 72 hours, the buyer shall within seven (7) days furnish the Breeder with a written veterinarian's certificate stating that the puppy was in ill health when examined. The Buyer assumes all associated shipping costs to return the puppy.

Under no condition will Breeder replace a puppy, where Breeder was not advised of puppy being ill beforehand, or 'put to sleep' without Breeder's permission.

No cash refund is ever made. A replacement puppy will only be given due to a life threatening illness and only if Breeder's negligence is in evidence as identified by a licensed veterinarian. The final disposition will be governed by a pathological tissue examination.

Should the puppy be diagnosed within one year of age with any genetic disorder which is considered by two unassociated veterinarians to seriously impact the quality of life, short of euthanasia, or requires continuous medical treatment throughout the course of the puppy's life, the Buyer has the option to return original puppy to Breeder, and the Breeder will upon provision of veterinary reports, provide Buyer with a replacement puppy as soon as one becomes available. We truly want you to have a healthy, happy bulldog, and will do all we can to provide that to you. We know hearts become attached to puppies, and it is hard to part with a puppy you've raised for a year if a defect should arise. Please know we will not euthanize a returned puppy, but will do all that we can to place any returned puppies with new owners that aware of and ready to provide the care needed for any issues the puppy may have due to a congenital defect.

At no point is Breeder responsible for any veterinarian fees you may incur while puppy is in your care. Please do not ask us to pay for vet fees, the answer will be no. We can however recommend local veterinarians that are familiar with bulldogs and well experienced with their healthcare and unique bulldog needs.

**Buyer's Responsibilities:**

The Buyer agrees to maintain preventative health care of the puppy including, but not limited to: inoculations, yearly physical exam by a licensed veterinarian, internal as well as external parasite treatments, heartworm preventative medication, and appropriate diet and exercise.

This puppy is sold with the understanding that it will live indoors, be socialized properly, and become a member of the family. Buyer agrees to maintain this dog in a safe environment.

This puppy was purchased as a companion and will be sold with a limited AKC registration. Buyer can decide to spay or neuter at their own discretion, however breeding of this puppy is not allowed regardless of decisions concerning reproductive sterilization.
